RACKGROUND

The Environmental Protection Agency (EPA) and Ministry of Transport (MOT) in collaboration with the United Nations Development Programme (UNDP) are currently implementing a project titled, "Strengthening Liberia's Capability to Provide Climate Information and Services to Enhance Climate Resilient Development and Adaptation to Climate Change". The project which is supported by the Global Environment Facility (GEF) through the Least Developed Country's Funds (LCDF) under the United Nations Framework Convention on Climate Change (UNFCCC) aims to set up an Early Warning System to help Liberia adapt to the negative impact of climate change in the face of economic development to ensure sustainability.

The project intends to overcome key barriers including:

- i) inadequate network of weather monitoring infrastructure;
- ii) limited knowledge and capacity to effectively predict future climate events;
- iii) limited co-ordination of hydro-meteorology activities;
- iv) lack of systematic forecasting of climate hazards and analysis of risks meaning no timely dissemination of warnings and climate information; and
- v) Lack of environmental databases for assessing the risks posed by climate variability and change.

The project is expected to be completed by the end of 2018. The EPA intends to utilize portion of the funding for this project to hire a consultant to develop a pro-poor compatible environmental and livelihood strategy. This strategy will help to support the Government of Liberia commitment to address poverty through the creation of economic opportunities that will in turn enhance the capacity and capabilities of local community dwellers to contribute to reducing the impact of climate change.

I. OBJECTIVE OF THE ASSIGNMENT

The general objective of this assignment is to develop a "pro-poor" compatible environmental and livelihood strategy to enable Liberians, especially the poor and underprivileged improve their economic and social livelihoods while also promoting sustainable use of the environment.

II. SCOPE OF WORK

The consultant will work closely with the Energy and Environment Coordinator at the Environmental Protection Agency to carry out the assigned task. The person will be expected to undertake a scoping exercise to provide baseline information on the environmental threats that local communities are exposed to and capacities of these communities to adapt to the negative impacts of climate change. The scoping exercise will be conducted through review of literature, discussions with key informants/stakeholders, and review of existing documents. The consultant will also be expected to collect social and economic data in selected communities in order to gauge poverty level, identify opportunities and challenges in implementing anticipated interventions, and determine intervention strategies that will be applicable and acceptable within the context of the target communities. Information from these activities will inform the development of an environmental and livelihood strategy in support of the national pro-poor agenda. This proposed strategy will create livelihood opportunities for underprivileged Liberians and increase communities' capacity to take actions to address climate change.

III. EXPECTED OUTPUTS

The following outputs are expected from this assessment which will be produced in the form of a written document:

- 1. Report from scoping exercise
- 2. Report from social and economic assessment
- 3. A draft pro-poor environmental and livelihood strategy outlining:
 - a. communication/information dissemination plan;
 - b. cost analysis and resource mobilization plan;
 - c. road map for implementation;
 - d. Framework for implementation monitoring and evaluation.

IV. DURATION OF ASSIGNMENT

The consultant is expected to complete the assignment within 45 working days stretched over a period of 2 months from the date of signing the contract.

- Relevant post-graduate (Master or PhD) degree is required in Environmental Studies, International Development, Climate Change, or other related fields
- At least 5 years of relevant experience in carrying out high level analytical work on policy development;

- Strong knowledge of environmental risk and mitigation measures in Liberia;
- In-depth understanding of the economic situation in Liberia;
- Ability to organize his/her work independently, but also to work as part of a team;
- Proven ability to deliver quality output work under tight deadlines and on time;
- Excellent command of written and spoken English
